South Australian immigrant

John SQUIRE

What would be needed in 1911 for John SQUIRE to leave his work in Bristol and hop on a boat bound for South Australia? A good answer is probably love! John was staying with his mother's brother, William GILL and his family while undertaking his apprenticeship in Bedminster, Bristol, Somersetshire. One daughter of William GILL and Sophia was Ethel GILL, who John had plenty of opportunity to get to know well. William was the brother of John SQUIRE's mother, so John and Ethel were first cousins.

There were certainly adverts in all the Somerset and Gloucestershire papers advertising for servants and labourers to come to South Australia for guaranteed work. John was a qualified wheelwright and coachbuilder, and it seemed that when he arrived in Adelaide, he went at once to Port Wakefield to work for the South Australian railways. Today, we might call him a specialist carpenter. Three years later, in 1914, Ethel GILL followed John to Adelaide, and they married the day she arrived in Adelaide. Ethel and John were first cousins, so is that why they came to live half-way around the world? I do not know what their families thought of the match-up, but John and Ethel never returned to Somerset to see their relatives. They did make a satisfying life for themselves in South Australia, and set up us descendants for a great future.

John SQUIRE is Jan's grandfather, and the earliest ancestor, Robert SQUIRE b c1660, is Jan's great x7 grandfather.


Source of the SQUIRE surname (from the FamilySearch website):

English: status name, occupational name, or a nickname from Middle English squyer, squer, skier, sker, northern Middle English swire (Old French escuyer, escuier) 'shield bearer, esquire, personal attendant to a knight; landowner below the rank of knight; young man of gentle birth; household attendant, retainer, page, messenger'. Many early bearers of this name were of modest means and cannot have been members of the gentry; in such cases the name may have been used hyperbolically for a low-ranking servant or as a nickname. By the 17th century, the term denoted any member of the landed gentry, but this is unlikely to have influenced the development of the surname.

Robert SQUIRE b c1660

The earliest ancestral SQUIRE I can find is Robert SQUIRE born around 1660, probably near Cadeleigh, some 6km south-west of Tiverton in Devon (see map), and 15km north of Exeter. This is a farming district, and Robert was most likely a farmer or farm labourer, but I can find no relevant records to discover more.

Robert married Grace WOODLAND in 1674, in Newton St Cyres. There may be a problem here with the dates, as this would make Robert only 14 years old at marriage. Possible, but the records back this far can be 'fluid' or incorrectly transcribed. Newton St Cyres is about 5km east of Cadeleigh. They had four boys according to Findmypast records, all born in Cadeleigh, the second of which was Robert SQUIRE, born 1689, in Cadeleigh, Devon.



Over several generations, the family gradually moved north, through Uplowman and Wiveliscombe, towards Minehead/Dunster in Somerset. Robert is the 5 x great grandfather of John SQUIRE.

Robert SQUIRE b1689

Robert SQUIRE was born in 1689 in Cadeleigh, Devon. Note that this was still using the old Julian calendar where the year ticked over on 26 March each year. He married Agnes STEVENS in 1719, in Uplowman Devon. They settled in this town, which is just to the east of Tiverton, some 10km from where Robert was born. This is still a farming region, so Robert Jnr was probably also a farm worker/labourer.

They had four children and the eldest, Symon, was born in 1721 in Uplowman, close to Tiverton Devon.

Robert jnr was born in Cadeleigh, marked as 1 on the map. His son Symon was born at Uplowman, marked as 2.



Symon SQUIRE b1721

Symon SQUIRE was baptised in Uplowman, Devon in July 1721. He married a local girl Ann SALTER in 1751 in Uplowman, and most likely continued in the farming tradition. They seem to have had only one child, a son, Robert, born in 1751, rather soon after their marriage. Uplowman is a small village about 6km north east of Tiverton, Devon, and south of Wiveliscombe, where later generations lived. Symon was probably an agricultural labourer, although the region also had significant mining and manufacturing activities occurring.

Robert SQUIRE b1751

Robert SQUIRE was baptised in Uplowman in 1751. I cannot find any record as to whether he had siblings. Robert married a pregnant Mary CHAVE in 1773, still in Uplowman, and they had five children. The eldest was John, born in 1773 in Uplowman.

John SQUIRE b 1773

John SQUIRE was baptised in the parish church in Uplowman in 1773. He grew up in Uplowman, and married Elizabeth SCADDING in 1801, at the parish church Clyst St Lawrence, Devon, some 10km south of Uplowman. They moved North-East to Wiveliscombe in Somerset, where their eldest child Richard was born in 1814. John was around 40 years of age when the family moved north. We do not know their reasons nor motivation to make this move, but it was only around twenty km north of Uplowman.

Their younger son Isaac (senior) was born in 1815 a bit to the west in Upton. John would have been well into his forties by now, but Elizabeth was still in her thirties. This may indicate they had close family or friends close by that they wanted to be near to.

Isaac SQUIRE b1815

The SQUIRE family was in Wiveliscombe from about 1805 till 1886, when they moved even further north, to Alcombe, near Dunster. Isaac senior was born in 1815 in Wiveliscombe, and married Mary REDWOOD in 1838. They stayed close to Wiveliscombe while children were being born. However, Mary died in 1853 and Isaac married again in 1859, to Elizabeth HODGE. There seem to be two more children, but it is unclear whether they were born before or after this marriage. They had moved a bit further south, to Dulverton,

where their last child was born. There were nine children born to Isaac and Mary, the fifth being Isaac SQUIRE junior, born in 1846.

Wiveliscombe is at 1 in the map. 2 and 3 are farms where the SQUIRE family were recorded at Censuses. 4 is Exton where Isaac and Emily married. 5 and 6 are Alcombe near Dunster, but should be at 5.



Isaac SQUIRE b1846

Isaac junior was born in 1846, and spent his early life on farms near Wiveliscombe. He married Emily GILL, beginning a multi generation connection between the GILL and SQUIRE families. Emily had left her home in Alcombe to work as a servant in a nearby rectory at Exton, and married Isaac there in 1877. Emily's mother Mary died in 1886, so Isaac, Emily and the family moved to Staunton Cottage in Alcombe to support her father, James GILL. Emily and her brother William GILL had grown up nearby, before William moved to Bristol to marry and raise his family. His children included Ethel, soon to follow her cousin John (Isaac and Emily's third child) to Adelaide in South Australia. I was fortunate to visit Alcombe in 2003 and in 2007, and took photographs of Isaac and Emily's house, Staunton Cottage (see below).

Isaac and Emily had five children, and they had the SMITH family as neighbours. When Charlie SMITH's mum died quite young, Isaac and Emily fostered young Charlie for a few years while his dad looked after a very disabled sibling. Charlie was included with the family in the 1901 census.

John SQUIRE b1881

John SQUIRE was the third child of Isaac and Emily SQUIRE, born at Alcombe in 1881, on the Dunster Castle estate. By the 1901 census, he was described as a coach builder. In 1911, he was living in Bristol, boarding with his Uncle William GILL and his family, and still listed as a coach builder. John SQUIRE departed London in September 1911, on the ship *Athenic*, bound for Port Hobart. He definitely disembarked in Port Adelaide, and seems to have made his way quite quickly to Port Wakefield, where he worked for the South Australian Railways.

Ethel GILL, at almost 30 years of age, left London in September 1914 on the ship *Orsova*, alighting in Adelaide several weeks later. John met Ethel at Port Adelaide on her arrival, so that must have taken some planning.

The house at 16 Edward St., Port Wakefield, where John and Ethel lived from approx. 1913 to 1942.




John and Ethel married on the day she arrived in Adelaide, and they settled into Port Wakefield life, living at 16 Edward Street with their only child Ken, born 1917. The house looks like it should be condemned, and it seems that no-one is currently living there. But at least it still stands, and I have a recent photograph. The shed at the front of the house was used as his blacksmith shop, and also for John's carpentry and undertaker work. I have not yet discovered when John left the railways, but John appears to have become a blacksmith, identified as such in the Sands and Mac directories, and both John and Ethel were involved in their local Methodist Church. John may also have been the local undertaker for a while, because of several notices in local newspapers (accessed from Trove).

Interestingly, one of the witnesses to John and Ethel's marriage was Maude RANN, soon to marry Edwin RUNDLE, and the mother of Connie RUNDLE, who married Ken SQUIRE in June 1944. I suspect Maud was a person roped in by the Port Adelaide Methodist Church minister to be a witness when John and Ethel married, but she must have remained lifelong friends to them.

I have found mention of John SQUIRE in local papers. In the Wooroora Producer, a Balaklava newspaper, dated 27 May 1937, John and Ken are mentioned in news about a recent Literary Society meeting. Ken would have been 20 at this time. At the Literary meeting held in the Methodist Hall on Monday night, May 17th, Mr John Squire presided, and the following officers—nominated at the annual meeting—were elected: president—R Jones; vice-president—Dr E Brotchie; hon. secretary and treasurer—R Stone; assistant secretary—Miss E Liebich; general committee—above officers, together with Mrs Jones, Misses G Moore and D Peck, and Mr Ken Squire.

Reference was made to the valuable services rendered by the retiring president (J Squire), the secretary (G Tippett) and other officers during the year, and a minute of appreciation was recorded. Impromptu readings completed a very enjoyable and profitable evening. We can also see that John was the local undertaker for a time, and he had also been listed as a blacksmith. It was likely he would no longer have been employed by the Railways at this time. This notice was in The Advertiser (Adelaide), dated 13 April 1934.



John retired around 1941, and moved to Torrensville, Adelaide, where they bought a house in Stephens Avenue. Sadly, my grandmother Ethel, died there in April 1943, before I was born.

Kenneth SQUIRE b1917

Ken SQUIRE was born at Hamley Bridge in 1917, and carried on the surname as an only child. He married Constance (Connie) RUNDLE in 1944. It is understood that Ethel SQUIRE and Maude RUNDLE contrived to introduce Ken and Connie, and the partnership was formed. There are anecdotal stories that Ken was 'a bit of a lad' in his youth, but he certainly settled down after marriage. Ken and Constance RUNDLE married in 1944 at the Methodist Church, Port Adelaide.

After they married, Ken and Connie lived with John SQUIRE at Torrensville until John died in his sleep in 1952, unfortunately on brother Jeff's birthday. As a five and a half year old, I remember that morning well. Ken and Connie brought three children into this world, Graham in 1946, (later to morph into Jan), Jeffrey in 1949, and Valerie in 1956. There followed six grandchildren and five great grandchildren (as at August 2022).



Ken was 25 years of age in 1942, and he enlisted into the armed services in May 1942. He was discharged 6 weeks later, with his eyesight and one slightly shorter leg being the main reasons. He also had an essential job at this time with Horwood Bagshaw, who made farming equipment.

Ken trained as a fitter and turner, but he quickly started studying and became an Accountant (AASA) by about 1950. He worked freelance in the fifties, from an office at 308 North Terrace. He built a number of houses, including in Glenside and Beaumont that we lived in. From about 1956, Ken worked as the Administrator for the Congregational Church in South Australia. He was a lay preacher in the Methodist and then the Congregational church, and was instrumental in setting up Aged Care homes under the banner of the Congregational Church Homes for the Aged. These included Rose Park, Glengowrie (Alambi), Clayton and Maitland Congregational Homes for the Aged.

Connie died in 1974 after a difficult life with asthma and many allergies. Ken retired soon after. and moved to Glenalta. He had a few skirmishes with cancer during his lifetime, and he succumbed to Oesophageal cancer in 1984.

There are plenty of other SQUIRE families in Adelaide, but I have not yet found any connection to any of them. I have started a project to explore this further, and continue work on this infrequently as a personal one-name study. Any connection would have to be with families with connections in Somerset, and I continue to look.

Graham (Jan from 1997) SQUIRE b1946

Jan (then Graham) was the eldest son of Ken and Connie SQUIRE, born in 1946 at a Private hospital in Semaphore. I went to the Thebarton Infant School in 1952 and 1953, before the family moved to Glenside in January 1954. I spent the rest of my primary schooling at Linden Park Primary school, before attending Adelaide Boys High School 1960-63. I was not a great student, and left after Intermediate, having failed year 10 English. I subsequently passed year 10 English at night classes with Muirden College in the city. I studied and passed year 11 and 12 at night-school, by about 1975, and took an Economics degree with Adelaide University, which took about twelve years to complete. During these years, I switched to a Finance role within PMG, later Telecom then Telstra. I worked for the PMG etc from 1962 till 1992.

After leaving school, I applied for an apprenticeship with the SA Railways, but was rejected due to my eyesight. Having got glasses, I applied for entry to the Australian Public Service, not knowing what I wanted to do. Out of around 5,000 people who sat the entrance exam, I came fifth, and was quickly offered a job (December 1962) with the PMG, delivering telegrams. After 18 months, I began as a messenger, collecting/delivering papers, etc., around the Telecommunications Division. I then had a stint testing public telephones in the metro area, before obtaining my Leaving (year 11) certificate, and allowing me to advance to Division III, and a Clerk's role. I did customer service for a few years, which was enabling people to connect and disconnect landline telephones.

This was interrupted by two years of National Service. I 'won' the lottery and spent two years in the army from May 1967. I trained and worked as a telegraph technician, maintaining machines and a system that no longer exists. I topped the technicians training course, and so ensured I did not have to go to that scary place called Vietnam.

As I progressed with my university studies, I switched to the Finance and Accounts area, mainly in product accounting areas. I was conducting economic analyses on new products, and new ways of using them. I was an early user of computers and spreadsheets.

Outside of work, I had 'attached' myself to the Kensington Gardens Congregational Church Youth Group, after meeting Anne KEIGHTLEY on a Congregational Church organised hike to Cradle Mountain National Park in Tasmania. This was in Christmas 1965. I and others subsequently organised week-long hikes to Wilson's Promontory (Victoria), and several in the Flinders Ranges. Anne and myself began dating in 1966, and married in August 1970.

In the early 1970's, Anne and myself started organising cave exploration trips to the south-east of South Australia, initially through the Congregational Church, with up to 20 people coming for a three day excursion two or three times a year. Over several years, we were able to assist with mapping and exploring many caves in the Mount Gambier area.



When Anne and I married, Anne had land at Belair, which we built on. We moved to Hawthorndene in 1986, and then to Harrogate in 1995. Hopefully, our last move was in 2013 to Dover Gardens in a smaller house. Sadly, the large house at Harrogate was destroyed by fire at Christmas 2019, long after we left.

Between us, we have some significant community service activities. Anne and myself were foster parents to children with disabilities or challenging circumstances from around 1982. I was involved with the Belair Scout's Parent's committee, and I served on or ran a number of Landcare groups while we lived in Harrogate. I was a Justice of the Peace (JP) from 1997 till 2022. I was also Treasurer of Down Syndrome Society of SA from about 1995 till 2012. They ran a rock'n'roll monthly dance at Burnside from 2001, for people with disabilities, where I was resident DJ for the first ten years.

I seem to have acquired significant building skills over the years, with extensions at Belair and Hawthorndene. As owner-builder of our property at Harrogate, I laboured for the carpentry team, and did most of the finishing work, including plumbing and electrical, setting up the solar/wind/battery power system for the property. I took many years on first and second fix carpentry, and painting. I had an electrical trade certificate, although I never practiced as an electrician in SA.

We built the house in 1995, and sold the property in 2013. The house was destroyed by a large bushfire in 2019.

My gender identity was always an issue for me from a young age. I thought I should be female, but social norms decreed this to be impossible. At age 25 years, I worked out that my feelings made sense if I were female. In my 40's, I was seriously distressed about my gender, and was clinically depressed. In 1996, at age 50 years, I decided I must be female, and transitioned at the start of 1997. While still difficult, I was now 'normal', and was accepted by Anne and most family and friends. Anne took the burden of stress for some time after this, and we divorced in order that I could have my gender affirming surgery in 2000. Fortunately, I had a good job with a not-for-profit organisation to be able to pay for it. I have now been Jan for 25+ years (as at August 2022), and have never regretted my decision. Anne and I still share a house, and are very good friends.

My second job, this time as Jan, was with Employment Options Inc., in Mount Barker. I started there as Finance Manager in 1997. I retired in September 2010.

In recent years, I have further developed my computer programming skills, and have undertaken genealogy studies. I have qualifications in Australian and English records and research. I wrote my first serious computer program around 1983, with my Dick Smith 'System 80', having minimal memory (16K) and an audio cassette for analogue storage. I now have extensive family history data going back to at least the 1600's for most family lines. I am starting my third iteration of writing about Anne's and my ancestors, focussing on the eighteen or so people who came to South Australia.

I have been the volunteer webmaster for Genealogy SA, and a major achievement was getting their membership system working properly, and also getting the initial databases more accessible and searchable. I also served on the Genealogy SA Governing Council for two years. I am currently webmaster for the Australasian Federation of Family History organisations (AFFHO), and I maintain three websites for them. I have always been keen to improve my computer and technology abilities, and I have good programming and problem-solving skills. I have written several applications in BASIC, and in PHP/SQL. I am proficient with the Wordpress and Joomla systems.

In retirement, I try to walk regularly, but still spend lots of time at my computer on various projects. I have a number of complex Lego sets I have built, and I am sorting and selling a friend's large Lego collection for her. I am also digitising audio histories for a friend in Mount Gambier, as well as papers collected from the scientific writings of the Rev J TENISON-WOODS.
