Peter MCARTHUR 1805 – 1892

Peter MCARTHUR was born on the island of Mull in Argyllshire, Scotland in 1805. He grew up in the south-western part of the island of Mull, close to Iona, at a place called Creich. He is listed as a crofter on his first two marriage records, so life would have been fairly hard for him and his family. Sadly, his first two wives died here, so Peter married for a third time, to Isabella McLEAN.

Peter MCARTHUR was 47 years of age when he and all his family emigrated to Australia and arrived in Portland, Victoria, in 1852. He brought his third wife and all of his eleven children with him to start a new life in Mount Gambier. His first two wives had died young, so is that why he moved half-way around the world? There were also major changes to agriculture in Scotland at the time, and crofting was fast becoming an unwanted occupation, especially by landowners. He probably had many reasons to make the move to Australia, but he did board a ship headed to Canada via Australia, and they decided to hop off in Portland Victoria. Peter and Isabella moved to Mount Gambier immediately, and had one more child in the Mount. They would have made a significant contribution to the local population.

Origin of the Surname McARTHUR

Scottish: Anglicized form of Gaelic Mac Artair, 'son of Arthur' (see Arthur).

History: Clan Arthur is a Highland Scottish clan traditionally associated with lands on the northern shores of Loch Awe. In 1427 the chief of the clan was one of several Highland chiefs executed for treason by King James I; it is said that the clan never recovered. As a matter of fact, there were several different Highland families and septs of other clans bearing the name Mac Artair.

Edward ARTHUR b c1720

The earliest ARTHUR/McARTHUR I can be reasonably sure about is Edward ARTHUR, born around 1720, probably in Kilbarchan, Renfrewshire, in Scotland. He is only named on his son's baptism record, along with his wife Jeals/Giles GILMOUR. I cannot find a suitable baptism record for Edward senior. I did find a marriage record though, and he married in 1744 to Giles GILMOUR, in Paisley, now a suburb of Glasgow, about 10km to the west of the city. They had at least one child, Edward McARTHUR, born in 1745, in Kilbarchan.



Edward McARTHUR b1745

Edward McARTHUR (note the change of name), was born in Kilbarchan, Renfrewshire, in 1745. This is 15km west of Glasgow, just far enough away to be a separate village. Edward married Anne HOUSTOUN in 1761, in Kilbarchan, so she was probably a local girl. They had eight children, the sixth being Edward McARTHUR, born in 1771, in Kilbarchan. He had six brothers and a sister.

Edward McARTHUR b1771

Edward McARTHUR was born in 1771, still in Kilbarchan. I cannot find any marriage record, but he had at least a relationship with Janet McEACHERN, for they had six children together. Janet was eleven years younger than

Edward. Janet was born in the north-west of the isle of Mull, so Edward must have come here for work, or was following his love. The eldest child was Peter McARTHUR, born in 1805, on the Isle of Mull.

Peter McARTHUR b1805

Peter McARTHUR was born on the isle of Mull in 1805. He would eventually bring his family to South Australia, but he had a substantial life on the isles of Mull and Iona first. Peter's first marriage was at Kilfinichen, on the isle of Mull, to Christine LIVINGSTON in 1827. They had two children together, before Christine died. Peter then married Flora McDONALD on Iona in 1833. Flora' father occupied a cottage on Iona, which is most likely where Peter met her. Peter and Flora had six children by 1842 when Flora died from the effects of fever. Peter married again, to Isabella McLEAN in 1842 in Iona, so this was a quick turnaround after Flora died. He did have several children to look after, so there would have been some imperative to have care for the children. They had three children on the isle of Mull before deciding to come to Australia. One more child was born in Mount Gambier.

Peter probably had several reasons not to stay in Scotland. He lost two wives there, so it would be hard to stay there with all the memories. His occupation was a crofter at Creich, and crofting was fast disappearing as many house and land owners were reclaiming agricultural land to use for grazing sheep and cattle. Peter was probably being pushed out. Peter, Isabella and all their children (eleven) went to Liverpool in 1852, to hop on a ship going to Canada via Australia. We are not sure which country was Peter's main goal, but the family got off the 'Marmion' in Portland, Victoria, and immediately made their way to Mount Gambier by dray. There, Peter put his agricultural skills to work straight away, working for Dr Wehl for a few years, and then buying land near Compton, which he called Greenvale. This was very profitable, and he retired in his early eighties, before dying in 1892 at the respectable age of 87 years.

Christina McARTHUR b1838

Christina McARTHUR was born in 1838 most likely on Mull, although she was baptised on Iona. Christina was the fourth child of Peter's second wife Flora McDONALD. Christina was 14 years of age when she came to South Australia. Christina married Duncan BUCHANAN five years later at the age of 19 years, when Duncan was double that, at 38 years. They were a productive couple though, bringing ten children into the world, five boys and five girls. The family ran a farm and butchery at Square Mile, just south of Mount Gambier for many years. After Duncan died,

Christina had a large house built on Bay Road where she and the girls lived, while the boys continued on the farm. I have previously written a narrative for the BUCHANAN surname, which you can read.
